To be considered for a BRIDGE Scholarship you must submit the following information and documentation in one package.

You must be newly licensed within 6 months to 2 years of application**

Provide your date of initial GHAR membership _____

Provide two letters of recommendation:

Letters must be no more than 3 months old.

One letter must be from the manager or broker of the firm with which you are associated.

One letter must be a professional recommendation.

You must include a one-page, personal motivation statement letter (can include hardship, personal goals, etc.)

Awards are announced by the Bridge Committee/GHAR Board of Directors in November.

*Incomplete, unsigned or applications received after the deadline will not be considered.

**Reinstatements/name changes are not considered new GHAR members.
