DIRECTOR ELIGIBILITY REQUIREMENTS

To be eligible for nomination and election as a Director, a candidate must be a primary REALTOR® Member in good standing, have served as a member of a REALTOR® association committee for at least two (2) years. A generally elected Director shall not serve more than two (2) consecutive terms. After serving two consecutive terms as a generally elected director, to remain on the Board of Directors, an individual must be elected to be an officer. To be eligible for a third term, a generally elected Director, who is not elected to be an Officer, must go off of the Board of Directors for one year. Elected Directors may not serve in an Officer, Director, Chair, Co-Chair or Vice Chair role in any other local REALTOR® Association at the same time.

Director Job Description: Serve as a member of the Board of Directors whose responsibility is to guide the Association toward its goals in both policy and programs.

Responsibilities:

1. Serve as a voting member of the Board of Directors in making decisions to support the Strategic Plan of the Association.
2. Perform duties assigned by the President.
3. Attend Association meetings and functions as a representative of the Board of Directors.
